Kazuo KURODA has long been interested in international education development and policies in Asian nations, global and regional governance of education as well as internationalization of higher education. He graduated from Waseda University (B.A.), Stanford University (M.A.) and Cornell University (Ph.D.). He formerly held positions at the Overseas Development Council in Washington, D.C., the World Bank and Hiroshima University before coming to Waseda. He was also a Member of Japanese National Commission for UNESCO, Visiting Research Fellow at IIEP-UNESCO, Visiting Professor at the University of Tokyo and Dean of International Affairs at Waseda University. Currently, Kazuo serves as members of several advisory committees of the Japanese Government agencies and international organizations.
